These were: (1) Change the Ohlsson Sideport event from a Special Event to a Standard Event. This has been a popular Special Event country wide since 1984, and a SAM Champs Special Event since 1989. Adding this event would result in 6 each ignition and glow events, matching the number of events in these two specialties counting toward Sweepstakes points. (2) Adopt the new Taft (White Elephant) rules for the electric Texaco and LMR events. These rules appear to have worked well at recent meets.



Fox and McCoy LER Event This potential event was discussed at last months meeting. No degree of interest was expressed so the matter is dropped.

AMA Membership Requirement A letter was sent to the 17 SAM 27 members where our records were deficient regarding AMA membership status. Verification responses have been





received from about 10. To date only one will be assigned Associate status. Responses from the remaining 7 will be appreciated.

NEW BUSINESS

Crash & Bash - September 7 & 8 Prez Rod suspects that Rocco Ferrario may not be in a position to do the food purchasing this year and is looking for a volunteer. Miriam Schmidt has advised that there are a lot of staples on hand like ketchup, mustard, napkins, plates, etc. and whoever purchases supplies should check with her first. Rod volunteered to do the hamburger and hot dog cooking again this year. John Carlson and John Hlebcar will man the desk and handle money. Ed Hamler has applied for AMA sanction and will soon be sending out about 150 flyers to previous contestants. Rod will contact Rocco regarding balsa for prizes. More volunteers are needed for assistance with cooking and cleanup. Ed Hamler is considering some possible rule changes to "streamline" events participation. These changes would apply to the LER events only and would place no limit on attempts; the posting of one max would qualify the contestant for the flyoffs which would be scheduled relatively earlier on each day. Possible channel conflicts in the flyoffs would be handled by drawing straws and flying in heats. There would be no changes to the usual rules for Antique, Pure Antique or Texaco. Ed would appreciate comments regarding the LER changes.

TECHNICAL REPORT

Prez Rod's long awaited vacuum forming presentation finally took place. Between car troubles and moving his office, time has been a short commodity. Rod vacuum forms parts such as canopies, wheel pants or whatever else might be appropriate, mostly for scale models. The apparatus used is a vacuum box with suitable frames for holding and positioning the plastic sheet to be formed and the mold or plug of the part or parts. The apparatus is all home fashioned by Rod, pretty much in accordance with an article appearing in one of the model magazines a year or two ago. The vacuum box is about 12" X 10" in size and about 6" deep. The top and

bottom are masonite with the top perforated with about 1/8" holes spaced about 1/2" apart. One end of the box has an opening for connecting a vacuum cleaner hose. Rod took a section of appropriate diameter from a plastic baseball bat to insert in the hole and match the hose connection. Three wood frames with internal openings matching the box were made from about 1" X 3/4" stock. One frame was attached to the box about 3/4" below the top. Of the remaining two frames one had sharp brads inserted at about 1/2" intervals and the other had holes to match. The plastic sheet to be formed was placed between the latter two frames and held in place by the brads, this entire assembly then slips down over the top of the box supported by the frame attached to the box. To prevent excessive vacuum leaks, the box seams were sealed and gaskets placed where necessary on the movable parts.

Plugs or molds for the parts to be formed are made from balsa or other soft wood to the desired size and shape. Each is coated with epoxy to seal the surface. Sealing with dope is not suitable because of the temperatures involved. The plugs should have some degree of taper with no undercuts which would prevent removal of the plug from the formed part. In some cases such as wheel pants the parts must be formed in halves and later assembled. Such details as canopy framing may be added to the plug by gluing on strips of paper or card stock of appropriate thickness. Rod sometimes adds small blocks to the bottom of the plug to space them a small distance from the top of the box and allow the plastic sheet to conform fully to the plug.

Now we are ready to form some parts. Rod uses acrylic plastic of a thickness he judges to be appropriate to the size of the part to be formed. Here is where a little experience helps. Rod obtains plastic sheet wherever he can, sometimes salvaged from Christmas packages or purchased from art supply stores or maybe Tap Plastics. The sheet is impaled on the sharp brads and sandwiched between the two to frames. The oven is preheated to 325 degrees. The box and vacuum cleaner are made ready and the plugs

warmed in the oven. Now you have to work fast. Place the heated plugs on the box top and insert the frame with the sandwiched plastic into the oven only long enough for the plastic to soften and sag a little. (Be prepared for a few disappointments here until you get the feel of things.) At the magic moment the plastic is removed from the oven and the frames slid down over the top of the box at which time the vacuum cleaner is turned on and the plastic is magically sucked down over the plug forming the perfect part. In only a matter of a few seconds the plastic has cooled to where it can be removed and the parts trimmed to size as necessary. Rod said that it is sometimes possible to avoid the use of the oven and warm the plastic sheet with a heat gun while applying vacuum. A great presentation Rod - The Club thanks you.


SHOW & TELL

Nick Sanford Produced a rubber winder he had fashioned from a 25 cent garage sale egg beater. The double beater feature allows winding of a twin pusher as well as a single motor. The nylon gears were pinned to the shaft so tension would not pull the shafts out. Nick fashioned a side handle, shaped to fit fingers and extended the winding handle to improve leverage. Nice work Nick - bring in the twin pusher next meeting.

Ron Keil showed his recently purchased RJL Blue Streak 64 engine. According to Ron, it is basically an Orwick with ball bearings and a solid mounting flange. The cost was about \$250 including tax and shipping. Ron also showed a set of 9 assorted hobby knives in a case; \$15 from Harbor Freight.

Ed Hamler showed his in-progress SAM CHAMPS model. With the Meet taking place in Pensacola, FL, Ed plans to fly commercial airline and thus it would be difficult to take his normal complement of models. To resolve this dilemma Ed has figured a way to enter 9 events with one wing, one tail, two fuselages and 6 engines. The engines are one each Ohlsson19,23,29,33,a Veco 19 and a K&B 3.5. Ed put on the board a matrix of events and engines showing how he plans to do this - quite impressive! The model is a





70% Lanzo RC-1 with about 480 sq. in. wing area. The wing will be in two sections to fit with the two fuselages and tail into a specially made carrying case. Ed displayed the framed fuselages and expects to have the models completed and tested, probably for the Crash & Bash well in advance of the October SAM CHAMPS.


John Carlson showed his nearly completed 56" Tabi Brooklyn Dodger for RC Class A Ignition. Power will be an Elfin diesel. The model was covered with SAMSPAN with three coats of 50% SIG LiteCoat. The SAMSPAN was adhered with the UHU glue stick. John was very enthusiastic about the use of this product. The structure to which the covering was to attach was given a couple of coats of 50% nitrate dope to seal the wood. The UHU is then spread on these surfaces. If it tends to lump up or go

on unevenly it can be spread out with a finger tip, a plastic spreader or with a brush moistened with rubbing alcohol. The covering can be applied immediately in which case the UHU is still tacky, making repositioning a little difficult, however by brushing through the covering with rubbing alcohol the UHU becomes quite slippery making positioning very easy. The UHU can be allowed to set for hours or days before applying the covering and then activating with alcohol. To secure the covering in place and prevent further movement, the alcohol dampened covering can be touched with a hot trim iron. This method works well with wing undercamber providing the ribs and flush spars are given the dope and UHU treatment. After the covering is in place and the UHU set either by drying with time or the aid of heating with the trim iron, the SAMSPAN is shrunk


with a heat gun. Wrinkles or puckers not removed by shrinking can be reworked by the use of alcohol, the trim iron and pulling to stretch the covering. Shrinking and conforming is considered to be as good or better than any other product used by John. The color coats are yet to be applied. These will probably be with the use of the Higgins ink/thinner/dope mixture currently recommended by Starline. John also read two letters. One from Bob Holman who had high praise for the SAMSPAN - UHU combination. The other letter was from our Charleston, SC member Woodie Owen who seems to be having trouble with SAMSPAN. He savs "the end results are not great enough to make up for the PITA (pain in the ass) factor." To date the "fors" appear to outnumber the "againsts".

Membership


Membership is \$15 for the calendar year. After February, the dues for a new member will be prorated.
